1.	Candidates can apply for NEET (UG) “Online” only. <b>No offline application will be entertained.</b>
2.	Information Bulletin can be downloaded from the website <a href="http://www.cbseneet.nic.in">www.cbseneet.nic.in</a> .
3.	Online submission of Application Form may be submitted by accessing Board’s website <a href="http://www.cbseneet.nic.in">www.cbseneet.nic.in</a> . Instructions for Online submission of Application are available in the Information Bulletin and on the website <a href="http://www.cbseneet.nic.in">www.cbseneet.nic.in</a> . Candidates must follow the instructions strictly as given in the Information Bulletin and on website. Candidates not complying with the instructions shall be disqualified.
4.	Aadhaar number is required for submission of Application Form of NEET (UG)-2018. The use of Aadhaar for the candidates of NEET (UG)-2018 will result in accuracy of the candidate’s details. This will also help in ascertaining identities of the candidates at the examination centres in a convenient and hassle free manner. Aadhaar obviates the need for producing multiple documents to prove one’s identity. More details are available in point-10 of chapter-4
5.	<b>Candidates must retain the following documents with them as reference for future correspondence:</b> (a) At least three printouts of the <i>Confirmation Page of online</i> Application. (b) Proof of fee paid (i.e. Bank transaction details supported by confirmation page). (c) At least 5 copies of identical passport size Photograph that was scanned and uploaded on the Online Application. (d) Copy of the system generated Self Declaration in respect of candidates from State of J&K who have opted for seats under 15% All India Quota . (e) The State of Andhra Pradesh and Telangana have decided to join 15% All India Quota scheme. Hence, candidates of these states need not to furnish Self Declaration as required earlier.
6.	(a) Candidates must ensure that mobile numbers, e-mail ID filled in online Application form are their own or their parents’. The Board will make communication by SMS and/or e-mail on given mobile number and e-mail ID respectively only. (b) The CBSE will not be responsible for non-receipt of latest information due to wrong mobile number, e-mail ID and correspondence address filled in the Online Application Form. (c) The fee can only be remitted in the following ways: (i) By Credit Card/Debit Card; (ii) Net Banking/UPI; (iii) E-wallet of Common Services Centre and other service providers. (d) Final Submission of Online Application will remain incomplete and unsuccessful in case of failure to complete Step-3 of Online Application, i.e., non-payment of fee. Generation of confirmation page confirms that application has been submitted successfully. Non generation of confirmation page indicates that the process of payment of fee has not been completed and thus application has not been submitted successfully.
7.	Candidates must preserve the Admit Cards till their admission in MBBS/BDS Courses.
8.	Ensure that correct data is submitted in online application. Any correction pertaining to the photograph and signature of the candidate will be intimated through e-mail/SMS and the same will be available in the candidate’s login account. Other permissible corrections can also be carried through log-in account only during schedule fixed for the same. Candidates may ensure clear photograph and signature are uploaded. Thereafter, no request for correction(s) will be entertained.
9.	Eligibility of the candidate will be determined on the last date of submission of online application form.
IMPORTANT NOTES	
1.	NEET (UG) will be held on 6 <sup>th</sup> May, 2018 (Sunday).
2.	NEET (UG) will be held in single stage and would be an objective type test.
3.	Indian Nationals, Non Resident Indians (NRI’s), Oversees Citizen of India (OCI’s), Persons with Indian Origin (PIO’s) & Foreign Nationals are eligible to appear in NEET (UG)-2018.
4.	Only one application is to be submitted by a candidate.
5.	Particulars filled in application form may be chosen carefully as options once exercised cannot be changed later including examination centre city and Language of Question Paper.
6.	Allotment of centre is made by Computer and there is no human intervention. Under no circumstances, the allotted centre shall be changed by the Board.
7.	The candidates can download Admit Card for the Examination from website <a href="http://www.cbseneet.nic.in">www.cbseneet.nic.in</a> .
8.	The candidates can download the Result, Marks cum Rank Sheet/Rank Letter from the website <a href="http://www.cbseneet.nic.in">www.cbseneet.nic.in</a> . These documents will also be made available in DigiLocker- <a href="http://www.digilocker.gov.in">www.digilocker.gov.in</a> .
9.	For the latest updates, candidates must remain in touch with the website <a href="http://www.cbseneet.nic.in">www.cbseneet.nic.in</a> , <a href="http://www.mohfw.nic.in">www.mohfw.nic.in</a> & <a href="http://www.mcc.nic.in">www.mcc.nic.in</a> and the websites of concerned States/Institutions till the completion of final round of counseling.
10.	Candidates should fill-up online form and pay fee well in advance to avoid last hour rush on the server. No request regarding non-submission of application/fee (due to any reason) will be entertained.

Chapter	<h1>1 INTRODUCTION</h1>
1	<p><b>NATIONAL ELIGIBILITY CUM ENTRANCE TEST (UG)</b></p> <p>As per regulations framed under the Indian Medical Council Act-1956 as amended in 2018 and the Dentists Act-1948 as amended in 2018, NATIONAL ELIGIBILITY CUM ENTRANCE TEST (UG) – 2018 (NEET-UG-2018) will be conducted by the Central Board of Secondary Education (CBSE), for admission to MBBS/BDS Courses in India in Medical/Dental Colleges run with the approval of Medical Council of India/Dental Council of India under the Union Ministry of Health and Family Welfare, Government of India except for the institutions established through an Act of Parliament i.e. AIIMS and JIPMER Puducherry.</p> <p><b>Following is stated in the regulations :-</b></p> <ol style="list-style-type: none"> <li>There shall be a single eligibility cum entrance examination namely ‘National Eligibility-cum-Entrance Test for admission to MBBS/BDS courses in each academic year.</li> <li>In order to be eligible for admission to MBBS/BDS Courses for a particular academic year, it shall be necessary for a candidate to obtain minimum marks in ‘National Eligibility-cum-Entrance Test’ held for the said academic year besides obtaining minimum prescribed marks at the qualifying examination.</li> <li>The reservation of seats in Medical/Dental colleges for respective categories shall be as per applicable laws prevailing in States/Union Territories. An All India Merit List of the eligible candidates shall be prepared on the basis of the marks obtained in National Eligibility-cum-Entrance Test for admission in MBBS/BDS courses from the said lists only.</li> <li>No candidate who has failed to obtain the minimum eligibility marks as prescribed by the Medical Council of India/Dental Council of India shall be admitted to MBBS/BDS Courses in the said academic year.</li> <li>All admissions to MBBS/BDS courses within the respective categories shall be based solely on marks obtained in the National Eligibility-cum-Entrance Test (UG).</li> <li>The Central Board of Secondary Education shall be the organization to conduct National Eligibility-cum-Entrance Test for admission to MBBS/BDS courses.</li> </ol> <p>As per the directives of the Hon’ble Supreme Court of India in WP (C) 390/2017 dated 10.08.2017, the comprehensive affidavit as to how CBSE is going to conduct examination in future, was placed alongwith draft Information Bulletin before the Hon’ble Supreme Court of India. CBSE will therefore, hold NEET (UG), 2018 in compliance of the orders dated 25.01.2018.</p> <p>The Central Board of Secondary Education will conduct the National Eligibility Cum Entrance Test for admission to MBBS/BDS Courses in the session 2018-19 on 6<sup>th</sup> May, 2018 (Sunday).</p> <ul style="list-style-type: none"> <li>The responsibility of CBSE is limited to the conduct of the entrance test, declaration of result and providing All India Rank to the Directorate General of Health Services, Ministry of Health and Family Welfare, Government of India for counselling of 15% All India Quota Seats, Deemed Universities/Central Universities/Seats of ESIC &amp; AFMC including BHU &amp; AMU and providing the result to the State Counselling Authorities and Admitting Institutions.</li> <li>The result of NEET (UG) may be utilized by other entities of Central/State Governments for admission purpose in accordance with their rules.</li> <li>The Counselling for successful candidates under 15% All India Quota seats, Deemed Universities/Central Universities/Seats of ESIC &amp; AFMC including BHU &amp; AMU will be conducted by the MCC/DGHS. The counselling for admission in seats under the control of other States/Universities/Institutions shall be conducted as per the notifications issued separately by the authorities concerned.</li> <li>During counselling, the eligibility criteria, self-declaration, various documents, etc. of the eligible candidates shall be verified as per norms specified by the respective authorities and Medical/Dental Colleges.</li> </ul> <p><b>Admissions to all seats of MBBS/BDS will be done through NATIONAL ELIGIBILITY CUM ENTRANCE TEST (UG) - 2018. There are following quota seats available: -</b></p> <ol style="list-style-type: none"> <li>All India Quota Seats</li> <li>State Government Quota Seats</li> <li>Central Institutions/Universities/Deemed Universities</li> <li>State/Management/NRI Quota Seats in Private Medical / Dental Colleges or any Private University</li> <li>Central Pool Quota Seats</li> </ol>

<b>4</b>	<p><b>DATE OF ENTRANCE TEST</b></p> <p>NATIONAL ELIGIBILITY CUM ENTRANCE TEST (UG) will be conducted on 6<sup>th</sup> May, 2018 (Sunday) from 10.00 AM to 1.00 PM. The duration of test will be 3 hours.</p> <p>The schedule will remain unaltered even if the date of test is declared a public holiday.</p>

## GENERAL INSTRUCTIONS

- (a) NATIONAL ELIGIBILITY CUM ENTRANCE TEST (UG) - 2018 will be conducted as per regulations framed under the Indian Medical Council Act-1956 as amended in 2018 and the Dentists Act-1948 as amended in 2018.
- (b) Mere appearing and qualifying in NEET (UG) does not confer any right to the candidate for admission in MBBS/BDS Courses. The selection and admission to MBBS/BDS seats in any Medical Institution recognized for offering MBBS/BDS Courses is subject to fulfilling the admission criteria, eligibility, rank in merit list, medical fitness and such other criteria as may be prescribed by the Government of India, respective States, Universities and Medical/Dental Colleges.
- (c) Applications of candidates submitting false and fabricated information will not be considered and such candidates will be further debarred from appearing in examinations conducted by the CBSE.
- (d) Incomplete application and applications not in accordance with instructions will not be considered and are liable to be rejected. The examination fee deposited will not be refunded in such cases.
- (e) Fee will neither be carried forward to a future examination nor refunded under any circumstances. Submission of online application and remittance of fee would close as per the schedule given and no request for extension of time etc. shall be entertained. Applications once submitted cannot be withdrawn. Candidates must note that mere deduction of fee from the bank account is not a proof of fee payment. The payment should be supported by updated fee in the account of the candidate and generation of confirmation page.
- (f) Instructions in the Information Bulletin are liable to change based on decisions taken by the CBSE and other authorities from time to time.
- (g) CBSE reserves the right to withdraw permission, if any, granted inadvertently to any candidate who is not eligible to appear in the NEET (UG) even though the Roll Number and Admit Card has been issued by the Board.
- (h) Candidate's eligibility for NEET (UG) is purely provisional and is subject to fulfilment of eligibility criteria as prescribed by the MOH&FW/MCI/DCI/CBSE/MCC.
- (i) In case of any ambiguity in interpretation of any of the instructions/terms/rules/criteria regarding determination of eligibility/conduct of examination/registration of candidates/information contained therein, the interpretation of the CBSE shall be final and binding.
- (j) The conduct of NEET (UG) Examination would be videographed. The candidates are required to keep their head in upright position and face the camera during the videography so that their identity could be clearly established.

## PATTERN OF NEET (UG)

## (a) Pattern of the Entrance Test:-

The Entrance Test shall consist of one paper in all languages containing 180 objective type questions (four options with single correct answer) from Physics, Chemistry and Biology (Botany & Zoology) to be answered on the specially designed machine-gradable sheet using Ball Point Pen provided by CBSE at examination centre only.

## (b) The duration of test would be 03 hours.

## (c) Language of the Question Papers:-

- ii) Option of medium of Question Paper should be exercised while filling in the application form and the option once exercised by candidates cannot be changed later.
- iii) Candidates opting for English would be provided Test Booklet in English only.
- iv) Candidates opting for Hindi would be provided Bilingual Test Booklet i.e. in Hindi and in English.
- v) Candidates opting for regional languages would be provided Bilingual Test Booklet i.e. in selected regional language and in English.
- vi) In case of any ambiguity in translation of any of the questions, its English version shall be treated as final.

In case, instructions are not complied with, CBSE may allot the centres different from the choice given or cancel the candidature.</li> <li>(d) In case, the number of candidates opting for a city as centre is less, Board reserves its discretion not to fix the centre in that City.</li> <li>(e) In case, the number of candidates opting for a city as centre with regional language (other than English and Hindi) is less, candidates opting same regional language may be allotted centre in one city irrespective of the city opted by the candidates for appearing in examination.</li> <li>(f) The candidates who have passed or appearing in class XII examination from the State of J&amp;K, Assam and Meghalaya (if not having Aadhaar Card) and registering themselves with other valid Government Identity number, should select the city of examination in these States only.</li> <li>(g) Though, every effort will be made to allot a centre in one of the city selected by the candidate, yet the Board reserves its discretion to allot a centre other than the candidate's choice.</li> <li>(h) Allotment of centre is made by Computer and there is no human intervention. # 3 ELIGIBILITY AND QUALIFICATIONS

## 1 ELIGIBILITY TO APPEAR IN NEET (UG)

Eligibility for appearing in NEET (UG) is as stipulated in Indian Medical Council Act-1956/Regulations as amended in 2018 and the Dentists Act-1948/Regulations as amended in 2018. Eligibility as per related regulations is as follows:-

- He/she has completed age of 17 years at the time of admission or will complete the age on or before 31st December of the year of his/her admission to the 1<sup>st</sup> year MBBS/BDS Course.
- The upper age limit for NEET(UG) is 25 years as on the date of examination with relaxation of 5 years for the candidates belonging to SC/ST/OBC category and persons entitled for reservation under the Rights of Persons with Disabilities Act, 2016.

The Age criteria for appearing in NEET (UG) - 2018 is as follows:

For Candidates of Unreserved Category (UR)	born on or between 07.05.1993 and 01.01.2002
For Candidates of SC/ST/OBC/PH Category	born on or between 07.05.1988 and 01.01.2002

- Indian Nationals, Non Resident Indians (NRIs), Oversees Citizen of India (OCIs), Persons with Indian Origin (PIOs) & Foreign Nationals are eligible to appear in NEET (UG)-2018.  
(As per letter no. U.12023/16/2010-ME-II dated 13.01.2016. of MoH & FW)

## 2 ELIGIBILITY FOR SEATS UNDER THE CONTROL OF STATES/ DEEMED UNIVERSITIES/CENTRAL UNIVERSITIES/SEATS OF ESIC & AFMC INCLUDING BHU & AMU/CENTRAL POOL QUOTA

- Indian Nationals, Non Resident Indians (NRIs), Oversees Citizen of India (OCIs), Persons with Indian Origin (PIOs) & Foreign Nationals are eligible for admission in Medical/Dental Colleges subject to rules and regulations framed by the respective State Governments, Institution and the Government of India.
- Foreign nationals may confirm their eligibility from the concerned Medical/Dentals College/State.

## 3 ELIGIBILITY FOR 15% ALL INDIA QUOTA SEATS

- Indian Nationals, Non Resident Indians (NRIs), Oversees Citizen of India (OCIs), Persons with Indian Origin (PIOs) & Foreign Nationals are eligible for 15% All India Quota Seats.
- Candidates from State of J & K
  - Students from State of J & K are NOT ELIGIBLE for 15% all India quota seats as State of J&K has opted out of All India Scheme since its inception. If they claim eligibility, they must submit online Self Declaration which will be generated and printed automatically alongwith confirmation page for the record and to present during counselling. The draft self-declaration is given in Appendix – III.
  - The online Self Declaration of the candidates will be verified at the time of counselling and if found to be false at any time, the candidature/admission of such candidates shall be cancelled and criminal proceedings may be initiated against them.
  - Candidates from the State of J & K can appear in NEET (UG) for admission to Private Medical/Dental Colleges or any Private/Deemed University and Armed Forces Medical College (AFMC), Pune subject to the fulfilment of eligibility conditions.
  - The Government of Andhra Pradesh & Telangana vide their letter no.13021/C1/2016 dated 06.11.2017 & letter no.7072/C1/2017 dated 07.11.2017 respectively have informed that Government of Andhra Pradesh and Government of Telangana have decided to join and contribute to the All India Quota seats. Accordingly, the candidates of these States have also become eligible for 15% All India Quota seats (As per letter No. F.No. V.26012/05.2017-MEP/MEC dated 10.01.2018, Directorate General Health Services, Ministry of Health & Family Welfare, Govt. of India)

## 4 QUALIFICATIONS AND QUALIFYING EXAMINATION CODES

### CODE : 01

A candidate who is appearing in the qualifying examination, i.e., 12<sup>th</sup> Standard in 2018, whose result is awaited, may apply and take up the said test but he/she shall not be eligible for admission to the MBBS or BDS, if he/she does not pass the qualifying examination with the required pass percentage of marks at the time of first round of Counselling.

OR

### CODE : 02

The Higher/Senior Secondary Examination or the Indian School Certificate Examination which is equivalent to 10+2 Higher/Senior Secondary Examination after a period of 12 years study, the last two years of such study comprising of Physics, Chemistry, Biology/Bio-technology (which shall include practical tests in these subjects) and Mathematics or any other elective subject with English at a level not less than the core course for English as prescribed by the National Council of Educational Research and Training after introduction of the 10+2+3 educational structure as recommended by the National Committee on Education.

Provided that 2 year of regular and continuous study of Physics, Chemistry, Biology/Bio-technology taking together shall be required at 10+2 level for all the candidates. Candidates who have passed 10+2 from Open Schools or as private candidate shall not be eligible to appear for NEET (UG). Furthermore, study of Biology/Bio-technology as an additional subject at 10+2 level also shall not permissible.

NOTE: where the course content is not as prescribed for 10+2 education structure of the National Committee, the candidates will have to undergo a period of one year pre - professional training before admission to the Medical Colleges.

**(a) RESERVATION OF SEATS IN GOVERNMENT MEDICAL COLLEGES UNDER 15% ALL INDIA QUOTA:**

- (i) 15% seats are reserved for SC candidates,
- (ii) 7.5% seats are reserved for ST candidates,
- (iii) 27% seats as per Central Act are reserved for non-creamy layer OBC candidates only in Central Educational Institutions. Reservation would be applicable to the castes mentioned in the Central list of OBC. Thus, the candidates falling in this list may mention OBC-NCL in the Category Column in application form. Candidates from creamy layer and those who do not come under Central List of OBC are advised to mention their category as Unreserved (UR).

**(iv) Differently abled candidates as per MCI guidelines-are:**

Persons having Bench Mark disabilities and entitled for reservation under the Rights of Persons with Disability Act, 2016, 5% seats of the annual sanctioned intake capacity shall be filled up by candidates with Bench Marked Disabilities in accordance with the provisions of the Rights of Persons with Disabilities Act, 2016 based on the merit list of "National Eligibility Cum Entrance Test". For this purpose, the specified disability contained in the schedule to the Rights of Persons with Disabilities Act, 2016 is available at **Appendix-XIV**. If the seats reserve for the persons with disabilities in a particular category remain unfilled on account of unavailability of candidates, the seats should be included in the Annual Sanctioned Seats for the respective category. Detailed information in this regard is available on the website of Medical Counselling Committee – [www.mcc.nic.in](http://www.mcc.nic.in) and on website of the Ministry of Health and Family Welfare – [www.mohfw.nic.in](http://www.mohfw.nic.in)

Candidates who considered themselves eligible for this category are advised to ensure their eligibility by getting themselves examined at any Government Medical College/District Hospital/Government Hospital. - (v) Reservation will be made as per 2200 point reservation roster. The mode of implementation of reservation will be available on DGHS website-[www.mohfw.nic.in](http://www.mohfw.nic.in).

**(b) ADMISSION IN STATE MEDICAL COLLEGES/UNIVERSITIES/INSTITUTIONS/PRIVATE MEDICAL COLLEGES FOR SEATS OTHER THAN 15% ALL INDIA QUOTA.**

- (i) Admission under State Quota Seats shall be subject to reservation policy and eligibility criteria prevailing in the State/Union Territory as notified by the respective State/Union Territory from time to time.
- (ii) The reservation of the seats in medical colleges for respective categories shall be as per applicable laws prevailing in State/Union Territory concerned.
- (iii) Admission to MBBS/BDS Courses in Private Medical Colleges shall be subject to policies of the Government of India/State/Union Territory.

**(c) ADMISSION TO DEEMED UNIVERSITIES/CENTRAL UNIVERSITIES/SEATS OF ESIC AND AFMC INCLUDING BHU AND AMU**

- (i) Admission to Deemed Universities/Central Universities/seats of ESIC including BHU and AMU will be conducted by DGHS and reservation policy will be as per rules and regulations of the concerned University or Institution.
- (ii) Admission to AFMC, Pune shall be subject to the norms prescribed by the Directorate General of Armed Forces Medical Services, Ministry of Defence, Government of India. Candidates who apply for NEET (UG) –2018 and also seeking admission in AFMC will also have to apply to AFMC on [www.afmc.nic.in](http://www.afmc.nic.in) / [www.afmcdgld.gov.in](http://www.afmcdgld.gov.in). The short listed candidates will be required to appear for a second stage Screening Test conducted by AFMC. Candidates are advised to contact AFMC for further and exact details. The counselling will be conducted by DGHS.

Accordingly, the same practice is being followed for NEET (UG), 2018.</p> <p>(a) The use of Aadhaar for the candidates of NEET (UG)-2018 will result in accuracy of the candidates' details. This will also help in ascertaining identities of the candidates at the examination centres in a convenient and hassle free manner. Aadhaar obviates the need for producing multiple documents to prove one's identity.</p> <p>(b) The provisions of the Aadhaar Act and Regulations under the Act have come into effect from 14th September 2016 and notifications to this effect have been published in the Official Gazette. Section 57 of the Aadhaar Act 2016 permits the use of Aadhaar number for establishing the identity of an individual for any purpose pursuant to any law or any contract to this effect.</p>

- (c) Accordingly, CBSE has decided to use Aadhaar for the candidates in NEET (UG)-2018, and notifies the following:
- i) Candidates, who are in possession of Aadhaar, shall enter Aadhaar number, name, date of birth & gender in online application for NEET (UG)-2018 for the purpose of his/her identity and authentication thereof.
  - ii) Candidates not yet enrolled for Aadhaar, are hereby required to make application for Aadhaar enrolment in case he/she is entitled to obtain Aadhaar as per section 3 of Aadhaar Act. Such applicant may visit any Aadhaar enrolment centre (list available at [www.uidai.gov.in](http://www.uidai.gov.in)) to get enrolled for Aadhaar.
  - iii) In order to facilitate such candidates who are not having Aadhaar, the CBSE has specially set up facilitation centres in each city of examination for the purpose of Aadhaar enrolment. The candidates can approach such facilitation centres who will not charge any amount from any applicant for Aadhaar enrolment. The list of the facilitation centre is available on [www.cbseneet.nic.in](http://www.cbseneet.nic.in). These candidates who have enrolled for Aadhaar and have not received Aadhaar should enter 14 digits Aadhaar Enrolment ID (including slash) printed on the Aadhaar enrolment slip at the time of filling online application form for NEET (UG)-2018.

No candidate shall be allowed to enter in the examination centre after 09.30 a.m. Therefore, kindly ensure that candidates must leave home well in advance considering all facts like traffic, location of the centre and weather conditions, etc. Candidates are expected to take their seats immediately after the opening of the Examination Hall.</li> <li>(b) The candidate must show, on demand, the Admit Card for admission in the Examination Hall. A candidate who does not possess the valid Admit Card shall not be admitted to the Examination Hall under any circumstances by the Centre Superintendent.</li> <li>(c) During the examination time, the invigilator will check Admit Card of the candidates to satisfy himself/herself about the identity of each candidate. The invigilator will also put his/her signatures in the place provided in the Answer Sheet on SIDE-1.</li> <li>(d) A seat with a roll number will be allotted to each candidate. Candidates must find out and occupy their allotted seats. The eligibility criteria are as follows:</p> <ol style="list-style-type: none"> <li>In order to be eligible for admission to MBBS/BDS Courses for a particular academic year, it shall be necessary for a candidate to obtain minimum of marks at 50<sup>th</sup> percentile in National Eligibility Cum Entrance Test to MBBS/BDS Courses held for the said academic year. However, in respect of candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes, the minimum marks shall be at 40<sup>th</sup> percentile. In respect of the candidates with Bench Marked Disabilities specified under the Rights of Persons with Disabilities Act, 2016, the minimum marks shall be at 45<sup>th</sup> percentile for General category candidates and 40<sup>th</sup> percentile for SC/ST/OBC candidates. The percentile shall be determined on the basis of highest marks secured in the All India common merit list in National Eligibility Cum Entrance Test for admission to MBBS/BDS courses.</li> <li>Provided when sufficient number of candidates in the respective categories fail to secure minimum marks as prescribed in National Eligibility Cum Entrance Test held for any academic year for admission to MBBS/BDS Courses, the Central Government in consultation with Medical Council of India and Dental Council of India may at its discretion lower the minimum marks required for admission to MBBS/BDS Courses for candidates belonging to respective categories and marks so lowered by the Central Government shall be applicable for the said academic year only.</li> <li>To be eligible for admission to the MBBS/BDS Courses, a candidate must have passed in the subjects of Physics, Chemistry, Biology/Bio-technology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry, Biology/Bio-technology at the Qualifying Examination as mentioned in Graduate Medical Education Regulations-1997 as amended in 2018 and BDS Course Regulations, 2007 and in addition must have come in the merit list of National Eligibility Cum Entrance Test for admission to MBBS/BDS Courses. In respect of the candidates belonging to the SC, ST and OBC category, the marks obtained in Physics, Chemistry, Biology/Bio-technology taken in qualifying examination and competitive examination (Physics, Chemistry, Biology) be 40% marks instead of 50%. In respect of the candidates with Bench Marked Disabilities specified under the Rights of Persons with Disabilities Act, 2016, the minimum marks in qualifying examination in Physics, Chemistry and Biology/Bio-Technology taken together be 45% instead of 50% for General category candidates and 40% for SC/ST/OBC candidates.-Provided that 2 years of regular and continuous study of Physics, chemistry and Biology/Bio-Technology taken together shall be required at 10+2 level for all the candidates. Candidates who have passed 10+2 from open schools or as a private candidate shall not be eligible to appear for National Eligibility Cum Entrance Test (UG). Furthermore, study of biology/bio-technology as an additional subject at 10+2 level also shall not permissible. Provided that a candidate who has appeared in the qualifying examination, the result of which has not been declared, he may be provisionally permitted to take up the competitive entrance examination and in case of selection for admission to the MBBS/BDS courses, he/she shall not be admitted to that course until he/she fulfils the eligibility criteria as specified above. ## INTRODUCTION

It is expected that in National Eligibility Cum Entrance Test, a large number of candidates from India and abroad will appear. Certainly when they will apply in NEET, they may face some problems on different issues. One of the biggest concerns of the CBSE is how to provide upto date information to the aspirant candidates at the earliest and in the easiest manner.

It is considered that if candidates are having proper information, then only they can submit their application form for NEET without any problem. CBSE had made many efforts to provide the desired information to the candidates.

**The initiatives are as under:-**

- **NEET WEBSITE**  
Website has been made informative and user friendly so that any candidate can explore the website for easy access of information.
- **INFORMATION BULLETIN**  
Information Bulletin has been developed chapter wise so that all related information is available at one place.
- **FREQUENTLY ASKED QUESTIONS**  
Frequently Asked Questions have been hosted on website. These have been prepared based on the previous years experience on the query raised by the candidates and also based on new information for NEET (UG)-2018.
- **REPLICA OF THE APPLICATION FORM ON WEBSITE**  
Replica of the application form has been developed and a link has been given on website with a view that all the candidates before submission of application form will go through the replica, gather the desired information and then submit their application form. This replica is exactly the same as you will see at the time of submission of application form.
- **APPLICATION FORMAT**  
A format of application has also been developed by giving instructions that what information is to be filled in by the candidates. This format has been uploaded on the website [www.cbseneet.nic.in](http://www.cbseneet.nic.in) with a view that all the candidates before submission of application form must fill in the same format so that based on the same they can fill their application correctly.
- **INSTRUCTIONS AT THE TIME OF SUBMISSION OF APPLICATION FORM**  
A modern method has been used to develop the application of NEET in which candidate will be guided on each step that what information is to be given. Following the online instructions, application could be submitted correctly.

However, it has been observed that despite the above efforts, candidates are not adhering to the instructions given by CBSE which lead to wrong submission of application form. Thereafter, candidates will request the CBSE to rectify the mistake committed by them.

The submission of application has further been upgraded in which candidate can save the draft of application and once, they are certain that information given is correct, application could be submitted by them finally.

**The CBSE has put in place a candidates friendly, strengthened Grievance Redressal System to ensure quick redressal of candidates grievances in NEET (UG)-2018. This is the only correct method of getting the grievance redressal. In this system, the candidates will login in their login account with their registration number and password and thereafter they will send their request as per steps given below:-**

1. Login with given credentials i.e. application no. and password into your account.
2. Choose the subjects from the drop-down menu.
3. Enter the details of request/grievance in a crisp and clear language not more than 1200 characters.
4. The reply of request/grievance can be checked online by the candidate after login, into his/her account afterwards.

**Note: Offline requests/grievances or those sent via email by the candidates already registered and desirous of appearing in NEET (UG)- 2018 will not be considered.**

# PHYSICS

## CONTENTS CLASS XI SYLLABUS

### UNIT I: Physical World and Measurement

- **Physics:** Scope and excitement; nature of physical laws; Physics, technology and society.
- **Need for measurement:** Units of measurement; systems of units; SI units, fundamental and derived units. Length, mass and time measurements; accuracy and precision of measuring instruments; errors in measurement; significant figures.
- Dimensions of physical quantities, dimensional analysis and its applications.

### UNIT II: Kinematics

- Frame of reference, Motion in a straight line; Position-time graph, speed and velocity. Uniform and non-uniform motion, average speed and instantaneous velocity. Uniformly accelerated motion, velocity-time and position-time graphs, for uniformly accelerated motion (graphical treatment).
- Elementary concepts of differentiation and integration for describing motion. *Scalar and vector quantities:* Position and displacement vectors, general vectors, general vectors and notation, equality of vectors, multiplication of vectors by a real number; addition and subtraction of vectors. Relative velocity.
- Unit vectors. Resolution of a vector in a plane-rectangular components.
- Scalar and Vector products of Vectors. Motion in a plane. Cases of uniform velocity and uniform acceleration- projectile motion. Uniform circular motion.

### UNIT III: Laws of Motion

- Intuitive concept of force. Inertia, Newton's first law of motion; momentum and Newton's second law of motion; impulse; Newton's third law of motion. Law of conservation of linear momentum and its applications.
- Equilibrium of concurrent forces. Static and Kinetic friction, laws of friction, rolling friction, lubrication.
- *Dynamics of uniform circular motion.* Centripetal force, examples of circular motion (vehicle on level circular road, vehicle on banked road).

### UNIT IV: Work, Energy and Power

- Work done by a constant force and variable force; kinetic energy, work-energy theorem, power.
- Notion of potential energy, potential energy of a spring, conservative forces; conservation of mechanical energy (kinetic and potential energies); non-conservative forces; motion in a vertical circle, elastic and inelastic collisions in one and two dimensions.

### UNIT V: Motion of System of Particles and Rigid Body

- Centre of mass of a two-particle system, momentum conservation and centre of mass motion. Centre of mass of a rigid body; centre of mass of uniform rod.
- Moment of a force, -torque, angular momentum, conservation of angular momentum with some examples.
- Equilibrium of rigid bodies, rigid body rotation and equation of rotational motion, comparison of linear and rotational motions; moment of inertia, radius of gyration. Values of M.I. for simple geometrical objects (no derivation). Statement of parallel and perpendicular axes theorems and their applications.

### UNIT VI: Gravitation

- Kepler's laws of planetary motion. The universal law of gravitation. Acceleration due to gravity and its variation with altitude and depth.
- Gravitational potential energy; gravitational potential. Escape velocity, orbital velocity of a satellite. Geostationary satellites.

**UNIT VII: Properties of Bulk Matter**

- Elastic behavior, Stress-strain relationship. Hooke's law, Young's modulus, bulk modulus, shear, modulus of rigidity, poisson's ratio; elastic energy.
- Viscosity, Stokes' law, terminal velocity, Reynold's number, streamline and turbulent flow. Critical velocity, Bernoulli's theorem and its applications.
- Surface energy and surface tension, angle of contact, excess of pressure, application of surface tension ideas to drops, bubbles and capillary rise.
- Heat, temperature, thermal expansion; thermal expansion of solids, liquids, and gases. Anomalous expansion. Specific heat capacity:  $C_p$ ,  $C_v$ - calorimetry; change of state – latent heat.
- Heat transfer- conduction and thermal conductivity, convection and radiation. Qualitative ideas of Black Body Radiation, Wein's displacement law, and Green House effect.
- Newton's law of cooling and Stefan's law.

**UNIT VIII: Thermodynamics**

- Thermal equilibrium and definition of temperature (zeroth law of Thermodynamics). Heat, work and internal energy. First law of thermodynamics. Isothermal and adiabatic processes.
- *Second law of the thermodynamics:* Reversible and irreversible processes. Heat engines and refrigerators.

**UNIT IX: Behaviour of Perfect Gas and Kinetic Theory**

- Equation of state of a perfect gas, work done on compressing a gas.
- *Kinetic theory of gases:* Assumptions, concept of pressure. Kinetic energy and temperature; degrees of freedom, law of equipartition of energy (statement only) and application to specific heat capacities of gases; concept of mean free path.

**UNIT X: Oscillations and Waves**

- Periodic motion-period, frequency, displacement as a function of time. Periodic functions. Simple harmonic motion(SHM) and its equation; phase; oscillations of a spring-restoring force and force constant; energy in SHM –Kinetic and potential energies; simple pendulum-derivation of expression for its time period; free, forced and damped oscillations (qualitative ideas only), resonance.
- Wave motion. Longitudinal and transverse waves, speed of wave motion. Displacement relation for a progressive wave. Principle of superposition of waves, reflection of waves, standing waves in strings and organ pipes, fundamental mode and harmonics. Beats. Doppler effect.

**CONTENTS OF CLASS XII SYLLABUS****UNIT I: Electrostatics**

- Electric charges and their conservation. Coulomb's law-force between two point charges, forces between multiple charges; superposition principle and continuous charge distribution.
- Electric field, electric field due to a point charge, electric field lines; electric dipole, electric field due to a dipole; torque on a dipole in a uniform electric field.
- Electric flux, statement of Gauss's theorem and its applications to find field due to infinitely long straight wire, uniformly charged infinite plane sheet and uniformly charged thin spherical shell (field inside and outside)
- Electric potential, potential difference, electric potential due to a point charge, a dipole and system of charges: equipotential surfaces, electrical potential energy of a system of two point charges and of electric dipoles in an electrostatic field.
- Conductors and insulators, free charges and bound charges inside a conductor. Dielectrics and electric polarization, capacitors and capacitance, combination of capacitors in series and in parallel, capacitance of a parallel plate capacitor with and without dielectric medium between the plates, energy stored in a capacitor, Van de Graaff generator.



**UNIT II: Current Electricity**

- Electric current, flow of electric charges in a metallic conductor, drift velocity and mobility, and their relation with electric current; Ohm's law, electrical resistance,  $V-I$  characteristics (linear and non-linear), electrical energy and power, electrical resistivity and conductivity.
- Carbon resistors, colour code for carbon resistors; series and parallel combinations of resistors; temperature dependence of resistance.
- Internal resistance of a cell, potential difference and emf of a cell, combination of cells in series and in parallel.
- Kirchhoff's laws and simple applications. Wheatstone bridge, metre bridge.
- Potentiometer-principle and applications to measure potential difference, and for comparing emf of two cells; measurement of internal resistance of a cell.

**UNIT III: Magnetic Effects of Current and Magnetism**

- Concept of magnetic field, Oersted's experiment. Biot-Savart law and its application to current carrying circular loop.
- Ampere's law and its applications to infinitely long straight wire, straight and toroidal solenoids. Force on a moving charge in uniform magnetic and electric fields. Cyclotron.
- Force on a current-carrying conductor in a uniform magnetic field. Force between two parallel current-carrying conductors-definition of ampere. Torque experienced by a current loop in a magnetic field; moving coil galvanometer-its current sensitivity and conversion to ammeter and voltmeter.
- Current loop as a magnetic dipole and its magnetic dipole moment. Magnetic dipole moment of a revolving electron. Magnetic field intensity due to a magnetic dipole (bar magnet) along its axis and perpendicular to its axis. Torque on a magnetic dipole (bar magnet) in a uniform magnetic field; bar magnet as an equivalent solenoid, magnetic field lines; Earth's magnetic field and magnetic elements.
- Para-, dia- and ferro-magnetic substances, with examples.
- Electromagnetic and factors affecting their strengths. Permanent magnets.

**UNIT IV: Electromagnetic Induction and Alternating Currents**

- Electromagnetic induction; Faraday's law, induced emf and current; Lenz's Law, Eddy currents. Self and mutual inductance.
- Alternating currents, peak and rms value of alternating current/ voltage; reactance and impedance; LC oscillations (qualitative treatment only), LCR series circuit, resonance; power in AC circuits, wattless current.
- AC generator and transformer.

**UNIT V: Electromagnetic Waves**

- Need for displacement current.
- Electromagnetic waves and their characteristics (qualitative ideas only). Transverse nature of electromagnetic waves.
- Electromagnetic spectrum (radio waves, microwaves, infrared, visible, ultraviolet, x-rays, gamma rays) including elementary facts about their uses.

**UNIT VI: Optics**

- Reflection of light, spherical mirrors, mirror formula. Refraction of light, total internal reflection and its applications optical fibres, refraction at spherical surfaces, lenses, thin lens formula, lens-maker's formula. Magnification, power of a lens, combination of thin lenses in contact combination of a lens and a mirror. Refraction and dispersion of light through a prism.
- Scattering of light- blue colour of the sky and reddish appearance of the sun at sunrise and sunset.
- *Optical instruments:* Human eye, image formation and accommodation, correction of eye defects (myopia and hypermetropia) using lenses.
- Microscopes and astronomical telescopes (reflecting and refracting) and their magnifying powers.

- *Wave optics:* Wavefront and Huygens' principle, reflection and refraction of plane wave at a plane surface using wavefronts.
- Proof of laws of reflection and refraction using Huygens' principle.
- Interference, Young's double hole experiment and expression for fringe width, coherent sources and sustained interference of light.
- Diffraction due to a single slit, width of central maximum.
- Resolving power of microscopes and astronomical telescopes. Polarisation, plane polarized light; Brewster's law, uses of plane polarized light and Polaroids.

#### UNIT VII: Dual Nature of Matter and Radiation

- Photoelectric effect, Hertz and Lenard's observations; Einstein's photoelectric equation- particle nature of light.
- Matter waves- wave nature of particles, de Broglie relation. Davisson-Germer experiment (experimental details should be omitted; only conclusion should be explained).

#### UNIT VIII: Atoms and Nuclei

- Alpha- particle scattering experiments; Rutherford's model of atom; Bohr model, energy levels, hydrogen spectrum. Composition and size of nucleus, atomic masses, isotopes, isobars; isotones.
- Radioactivity- alpha, beta and gamma particles/ rays and their properties decay law. Mass-energy relation, mass defect; binding energy per nucleon and its variation with mass number, nuclear fission and fusion.

#### UNIT IX: Electronic Devices

- Energy bands in solids (qualitative ideas only), conductors, insulators and semiconductors; semiconductor diode- *I-V* characteristics in forward and reverse bias, diode as a rectifier; *I-V* characteristics of LED, photodiode, solar cell, and Zener diode; Zener diode as a voltage regulator. Junction transistor, transistor action, characteristics of a transistor; transistor as an amplifier (common emitter configuration) and oscillator. Logic gates (OR, AND, NOT, NAND and NOR). Transistor as a switch.

#### UNIT I: Some Basic Concepts of Chemistry

- *General Introduction:* Important and scope of chemistry.
- Laws of chemical combination, *Dalton's atomic theory:* concept of elements, atoms and molecules.
- Atomic and molecular masses. Mole concept and molar mass; percentage composition and empirical and molecular formula; chemical reactions, stoichiometry and calculations based on stoichiometry.

#### UNIT II: Structure of Atom

- Atomic number, isotopes and isobars. Concept of shells and subshells, dual nature of matter and light, de Broglie's relationship, Heisenberg uncertainty principle, concept of orbital, quantum numbers, shapes of s, p and d orbitals, rules for filling electrons in orbitals- Aufbau principle, Pauli exclusion principles and Hund's rule, electronic configuration of atoms, stability of half filled and completely filled orbitals.

#### UNIT III: Classification of Elements and Periodicity in Properties

- Modern periodic law and long form of periodic table, periodic trends in properties of elements- atomic radii, ionic radii, ionization enthalpy, electron gain enthalpy, electronegativity, valence.

#### UNIT IV: Chemical Bonding and Molecular Structure

- Valence electrons, ionic bond, covalent bond, bond parameters, Lewis structure, polar character of covalent bond, valence bond theory, resonance, geometry of molecules, VSEPR theory, concept of hybridization involving s, p and d orbitals and shapes of some simple molecules, molecular orbital theory of homonuclear diatomic molecules (qualitative idea only). Hydrogen bond.

**UNIT V: States of Matter: Gases and Liquids**

- Three states of matter, intermolecular interactions, types of bonding, melting and boiling points, role of gas laws of elucidating the concept of the molecule, Boyle's law, Charles's law, Gay Lussac's law, Avogadro's law, ideal behaviour of gases, empirical derivation of gas equation. Avogadro number, ideal gas equation. Kinetic energy and molecular speeds (elementary idea), deviation from ideal behaviour, liquefaction of gases, critical temperature.
- Liquid State- Vapour pressure, viscosity and surface tension (qualitative idea only, no mathematical derivations).

**UNIT VI : Thermodynamics**

- First law of thermodynamics-internal energy and enthalpy, heat capacity and specific heat, measurement of  $\Delta U$  and  $\Delta H$ , Hess's law of constant heat summation, enthalpy of : bond dissociation, combustion, formation, atomization, sublimation, phase transition, ionization, solution and dilution.
- Introduction of entropy as state function, Second law of thermodynamics, Gibbs energy change for spontaneous and non-spontaneous process, criteria for equilibrium and spontaneity.
- Third law of thermodynamics- Brief introduction.

**UNIT VII: Equilibrium**

- Equilibrium in physical and chemical processes, dynamic nature of equilibrium, law of chemical equilibrium, equilibrium constant, factors affecting equilibrium-Le Chatelier's principle; ionic equilibrium- ionization of acids and bases, strong and weak electrolytes, degree of ionization, ionization of polybasic acids, acid strength, concept of  $pH$ , Hydrolysis of salts (elementary idea), buffer solutions, Henderson equation, solubility product, common ion effect (with illustrative examples).

**UNIT VIII: Redox Reactions**

- Concept of oxidation and oxidation and reduction, redox reactions oxidation number, balancing redox reactions in terms of loss and gain of electron and change in oxidation numbers.

**UNIT IX: Hydrogen**

- Occurrence, isotopes, preparation, properties and uses of hydrogen; hydrides-ionic, covalent and interstitial; physical and chemical properties of water, heavy water; hydrogen peroxide-preparation, reactions, uses and structure;

**UNIT X: s-Block Elements (Alkali and Alkaline earth metals)**

- *Group 1 and group 2 elements:*
- General introduction, electronic configuration, occurrence, anomalous properties of the first element of each group, diagonal relationship, trends in the variation of properties (such as ionization enthalpy, atomic and ionic radii), trends in chemical reactivity with oxygen, water, hydrogen and halogens; uses.
- Preparation and Properties of Some important Compounds:
- Sodium carbonate, sodium chloride, sodium hydroxide and sodium hydrogencarbonate, biological importance of sodium and potassium.
- Industrial use of lime and limestone, biological importance of Mg and Ca.

**UNIT XI: Some p-Block Elements**

- General Introduction to p-Block Elements.
- *Group 13 elements:* General introduction, electronic configuration, occurrence, variation of properties, oxidation states, trends in chemical reactivity, anomalous properties of first element of the group; Boron, some important compounds: borax, boric acids, boron hydrides. Aluminium: uses, reactions with acids and alkalis.
- *General 14 elements:* General introduction, electronic configuration, occurrence, variation of properties, oxidation states, trends in chemical reactivity, anomalous behaviour of first element. Carbon, allotropic forms, physical and chemical properties: uses of some important compounds: oxides.
- Important compounds of silicon and a few uses: silicon tetrachloride, silicones, silicates and zeolites, their uses.

**UNIT XII: Organic Chemistry- Some Basic Principles and Techniques**

- General introduction, methods of purification qualitative and quantitative analysis, classification and IUPAC nomenclature of organic compounds.
- Electronic displacements in a covalent bond: inductive effect, electromeric effect, resonance and hyper conjugation.
- Homolytic and heterolytic fission of a covalent bond: free radicals, carbocations, carbanions; electrophiles and nucleophiles, types of organic reactions.

**UNIT XIII: Hydrocarbons**

- *Alkanes*- Nomenclature, isomerism, conformations (ethane only), physical properties, chemical reactions including free radical mechanism of halogenation, combustion and pyrolysis.
- *Alkenes*-Nomenclature, structure of double bond (ethene), geometrical isomerism, physical properties, methods of preparation: chemical reactions: addition of hydrogen, halogen, water, hydrogen halides (Markovnikov's addition and peroxide effect), ozonolysis, oxidation, mechanism of electrophilic addition.
- *Alkynes*-Nomenclature, structure of triple bond (ethyne), physical properties, methods of preparation, chemical reactions: acidic character of alkynes, addition reaction of- hydrogen, halogens, hydrogen halides and water.
- *Aromatic hydrocarbons*- Introduction, IUPAC nomenclature; Benzene; resonance, aromaticity; chemical properties: mechanism of electrophilic substitution- Nitration sulphonation, halogenation, Friedel Craft's alkylation and acylation; directive influence of functional group in mono-substituted benzene; carcinogenicity and toxicity.

**UNIT XIV: Environmental Chemistry**

- *Environmental pollution*: Air, water and soil pollution, chemical reactions in atmosphere, smogs, major atmospheric pollutants; acid rain ozone and its reactions, effects of depletion of ozone layer, greenhouse effect and global warming-pollution due to industrial wastes; green chemistry as an alternative tool for reducing pollution, strategy for control of environmental pollution.

**UNIT III: Electrochemistry**

- Redox reactions, conductance in electrolytic solutions, specific and molar conductivity variation of conductivity with concentration, Kohlrausch's Law, electrolysis and Laws of electrolysis (elementary idea), dry cell- electrolytic cells and Galvanic cells; lead accumulator, EMF of a cell, standard electrode potential, Relation between Gibbs energy change and EMF of a cell, fuel cells; corrosion.

**UNIT IV: Chemical Kinetics**

- Rate of a reaction (average and instantaneous), factors affecting rates of reaction; concentration, temperature, catalyst; order and molecularity of a reaction; rate law and specific rate constant, integrated rate equations and half life (only for zero and first order reactions); concept of collision theory ( elementary idea, no mathematical treatment). Activation energy, Arrhenius equation.



**UNIT V: Surface Chemistry**

- *Adsorption*-physisorption and chemisorption; factors affecting adsorption of gases on solids, catalysis homogeneous and heterogeneous, activity and selectivity; enzyme catalysis; colloidal state: distinction between true solutions, colloids and suspensions; lyophilic, lyophobic multimolecular and macromolecular colloids; properties of colloids; Tyndall effect, Brownian movement, electrophoresis, coagulation; emulsions- types of emulsions.

**UNIT VI: General Principles and Processes of Isolation of Elements**

- *Principles and methods of extraction*- concentration, oxidation, reduction electrolytic method and refining; occurrence and principles of extraction of aluminium, copper, zinc and iron.

**UNIT VII: *p*- Block Elements**

- *Group 15 elements*: General introduction, electronic configuration, occurrence, oxidation states, trends in physical and chemical properties; preparation and properties of ammonia and nitric acid, oxides of nitrogen (structure only); Phosphorous- allotropic forms; compounds of phosphorous: preparation and properties of phosphine, halides ( $\text{PCl}_3$ ,  $\text{PCl}_5$ ) and oxoacids (elementary idea only).
- *Group 16 elements*: General introduction, electronic configuration, oxidation states, occurrence, trends in physical and chemical properties; dioxygen: preparation, properties and uses; classification of oxides; ozone. Sulphur – allotropic forms; compounds of sulphur: preparation, preparation, properties and uses of sulphur dioxide; sulphuric acid: industrial process of manufacture, properties and uses, oxoacids of sulphur (structures only).
- *Group 17 elements*: General introduction, electronic configuration, oxidation states, occurrence, trends in physical and chemical properties; compounds of halogens: preparation, properties and uses of chlorine and hydrochloric acid, interhalogen compounds oxoacids of halogens (structures only).
- *Group 18 elements*: General introduction, electronic configuration, occurrence, trends in physical and chemical properties, uses.

**UNIT VIII: *d* and *f* Block Elements**

- General introduction, electronic configuration, characteristics of transition metals, general trends in properties of the first row transition metals- metallic character, ionization enthalpy, oxidation states, ionic radii, colour, catalytic property, magnetic properties, interstitial compounds, alloy formation. Preparation and properties of  $\text{K}_2\text{Cr}_2\text{O}_7$  and  $\text{KMnO}_4$ .
- *Lanthanoids*- electronic configuration, oxidation states, chemical reactivity, and lanthanoid contraction and its consequences.
- *Actinoids*: Electronic configuration, oxidation states and comparison with lanthanoids.

**UNIT IX: Coordination Compounds**

- *Coordination compounds*: Introduction, ligands, coordination number, colour, magnetic properties and shapes, IUPAC nomenclature of mononuclear coordination compounds, isomerism (structural and stereo) bonding, Werner's theory VBT,CFT; importance of coordination compounds (in qualitative analysis, biological systems).

**UNIT X: Haloalkanes and Haloarenes**

- *Haloalkanes*: Nomenclature, nature of C –X bond, physical and chemical properties, mechanism of substitution reactions. Optical rotation.
- *Haloarenes*: Nature of C-X bond, substitution reactions (directive influence of halogen for monosubstituted compounds only).
- Uses and environment effects of – dichloromethane, trichloromethane, tetrachloromethane, iodoform, freons, DDT.

**UNIT XI: Alcohols, Phenols and Ethers**

**SPECIFIED DISABILITIES**

(As per PWD Act, 2016 and as given in amended regulations of MCI)

**1. Physical disability****A. Locomotor disability** (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both), including-

- (a) "leprosy cured person" means a person who has been cured of leprosy but is suffering from-
  - (i) loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifest deformity;
  - (ii) manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
  - (iii) extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly;
- (b) "cerebral palsy" means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth;
- (c) "dwarfism" means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimeters) or less;
- (d) "muscular dystrophy" means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterized by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue; (e) "acid attack victims" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.

**B. Visual impairment**

- (a) "blindness" means a condition where a person has any of the following conditions, after best correct-
  - (i) Total absence of sight; or
  - (ii) Visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or
  - (iii) Limitation of the field of vision subtending an angle of less than 10 degree.
- (b) "low-vision" means a condition where a person has any of the following conditions namely:-
  - (i) Visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or
  - (ii) Limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree

**C. Hearing impairment –**

- (a) "deaf" means persons having 70 DB hearing loss in speech frequencies in both ears;
- (b) "hard of hearing" means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears;

**D. "Speech and language disability"** means a permanent disability arising out of conditions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes.**2. Intellectual disability**, a condition characterized by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behaviour which covers a range of every day, social and practical skills, including-

- (a) "specific learning disabilities" means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia;
- (b) "autism spectrum disorder" means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.

3. **Mental behaviour** - “mental illness” means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behaviour, capacity to recognize reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterized by subnormality of intelligence.
4. **Disability caused due to –**
  - (a) **Chronic neurological conditions, such as-**
    - (i) “multiple sclerosis” means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelination and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other;
    - (ii) “parkinson’s disease” means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.
  - (b) **Blood disorder-**
    - (i) “haemophilia” means an inheritable disease, usually affecting only male but transmitted by women to their male children characterized by loss or impairment of the normal clotting ability of blood so that a minor would may result in fatal bleeding;
    - (ii) “thalassemia” means a group of inherited disorders characterized by reduced or absent amounts of haemoglobin.
    - (iii) “sickle cell disease’ means a hemolytic disorder characterized by chronic anemia, painful events, and various complications due to associated tissue and organ damage; “hemolytic” refers to the destruction of the cell membrane of red blood cells resulting in the release of haemoglobin.
5. Multiple Disabilities (more than one of the above specified disabilities) including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.
6. Any other category as may be notified by the Central Government.

Note: Any amendment to the Schedule to the RPWD Act, 2016, shall consequently stand amended in the above schedule.
