2. The cut-off percentage of marks in the above Preliminary Examination is as follows:

- (i) UR vacancies: 50% in each component and 68% aggregate for English Stream
50% in each component and 65% aggregate for Hindi Stream
- (ii) OBC vacancies: 45% in each component and 65% aggregate for English Stream
45% in each component and 64% aggregate for Hindi Stream
- (iii) SC vacancies: 40% in each component and 66% aggregate for English Stream
40% in each component and 64% aggregate for Hindi Stream
- (iv) ST vacancies: 40% in each component and 54% aggregate

The above percentages are relaxable by 5% in case of Physically Challenged Persons [Visually Impaired Persons – Low Vision (LV)] satisfying physical requirements mentioned in Advt. No. 7/2017.

3. The candidates should bring copies of the following certificates **duly attested by a First Class Magistrate or Gazetted Officer** at the time of Typing Test:

- (i) Matriculation or equivalent examination certificate as proof of date of birth
- (ii) Certificates/Degrees and marks sheets of all educational qualifications
- (iii) Category/Caste Certificate issued by the Competent Authority in case of SC, ST and OBC candidates
- (iv) Discharge Book in case of ex-Servicemen
- (v) PH Certificate in the format as prescribed in the advertisement
- (vi) The candidates working in a Government Department/Public Sector Undertaking/Lok Sabha Secretariat are required to furnish a certificate from her/his Employer on the office letter head in respect of length of her/his service.

The candidates not submitting caste/category certificate will be treated as 'General' category candidates and will not be provided any benefit available to the caste/category mentioned/claimed by her/him in the application.

The candidates belonging to OBC category will be required to submit a declaration attached with their Call Letter in addition to the category/community certificate.

4. The marks secured by the candidates are being put on our website <http://www.loksabha.nic.in> under the link 'Recruitment'.

5. Attention of the candidates is drawn to the following mentioned in Advertisement No. 7/2017:

The admission of candidates at all stages of examination will be purely provisional subject to satisfying the prescribed eligibility conditions.

The scrutiny of applications with regard to eligibility criteria i.e. age, educational qualification, category, etc., will be undertaken by Lok Sabha Secretariat at the time of preparation of final result. At that time, if any claim made by a candidate in the application is not found substantiated or supported by relevant documents/ certificates then her/his candidature will be cancelled and the decision of Lok Sabha Secretariat in this regard shall be final.

The candidate's Caste; the Act/Order under which the Caste is recognized as SC/ST/OBC; and the village/town the candidate is ordinarily a resident of, should be clearly indicated in the caste/category certificate.

In case of an OBC certificate issued prior to 08.08.2014, a fresh certificate incorporating therein the relevant provisions of DoPT OM Nos. 36033/3/2004 - Estt. (Res.) dated 14.10.2008 and 36033/1/2013- Estt.(Res.) dated 27.05.2013 pertaining to Creamy Layer must be got prepared inter-alia satisfying the conditions mentioned in Advertisement No. 7/2017.

All particulars (except Residential Address) furnished by the applicant in the online application will be treated as final and no change will be allowed therein later on.

6. The name of the post has been revised as 'Secretariat Assistant'. However, the revision of nomenclature doesn't involve change in duties and responsibilities and any additional financial benefits.
